## **BYLAWS (part 2)**

### **ARTICLE 6. DUTIES OF OFFICERS OF THE COUNCIL**

**SECTION 1. The Chair.** The Chair of the Association shall be the principal executive officers and the official spokesperson of the Association, and shall preside at all meetings of the Society. The Chair shall perform all duties usually incident to the office of Chair and such other duties as may be assigned to the Chair by the Council. The Chair shall make all appointments to subcommittees including the Editors of the official publications of the Association, and shall designate all official delegates and representatives to outside groups, subject to approved by the Council.

**SECTION 2. The vice-Chair.** The vice-Chair shall perform any and all duties assigned by Chair or by the Council. In the absence of incapacity of the Chair, the vice-Chair shall perform the duties of the Chair. The vice-Chair shall assure continuity of the business of the Association and shall recommend appointments for subcommittees, and other groups to take effect upon the vice-Chair assuming the office of the Chair.

**SECTION 3. The Treasurer.** The Treasurer is appointed by the Chair. The Treasurer shall perform all duties usually incident to the office of Treasurer and such other duties as may be assigned by the Chair or by the Council. The Treasurer shall oversee the funds of the Association, its financial polices and the preparation of an annual budget for approval by the Council. The Treasurer shall also provide a complete annual financial report.

**SECTION 4. Other Council Members:** The Council members are appointed by the Chair based on the recommendations from the previous Chair, vice-Chair or Council members. The Council members should perform all duties assigned by the Chair, or the Council. Each Council member shall oversee one subcommittee.

**SECTION 5. Members at Large.**

## **ARTICLE 7: MEETINGS, QUORUM, AND VOTING**

**SECTION 1. The Council Meetings.** The Councils shall meet annually. Special meetings may be called at any time by the Chair or by a two-thirds majority (5 members) of the Council members.

**Quorum.** A quorum consists of the majority (two-thirds) of the Council Members, present in person, or by audio link, for the purpose of conducting the business of the Association.

**Voting.** The majority (two-thirds) of the votes of the council members, present in person, or by audio link, or by ballots emailed to the members should be necessary for the adaption of any matter voted on unless otherwise specified.

**SECTION 2: Member Meetings.** Regular member meeting should take place in conjunction with reunion held every 3 years. Special meetings can be called by the Chair, by the Councils, or by petition signed by no less than one-fifth of the members. Small scale mini reunions can be held at any times by the members.

**Quorum.** A quorum consists of the majority (two-thirds) of those members, present in person, or by audio link, for the purpose of conducting the business of the Association.

**Voting.** The majority (two-thirds) of the votes of members, present in person, or by ballots emailed to the members should be necessary for the adaption of any matter voted on unless otherwise specified.

## **ARTICLE 8: MISCELLANEOUS PROVISIONS**

**SECTION 1, Fiscal Year.** The Association's fiscal year shall be calendar year.

**SECTION 2. Logo.** The Association's logo, if any, shall be such as may be approved by the Council. The use of the logo outside the context of The Association's regular functions and activities will need to be authorized by the council.

**ARTICLE 9: CODE FO ETHICS.** The society shall adopt the Code of Ethics of American Medical Association as part of its regulations.

**ARTICLE 10: AMENDMENTS**

Adoption, alteration or repeal of Operation Guidelines may be moved at the meeting/email conference of the Council. Amendments may be proposed by any member of The Association. Final passage shall require a majority vote (2/3) of the Council members responding.
